The LEAPS program

(Law Firms Encouraging and Assisting Promising Students)

We are proud to be the only law firm in Queensland running a LEAPS program (Law firms Encouraging and Assisting Promising Students) launching the pilot program in 2006. This program has been going for some years in NSW, and involves staff mentoring of students in grade 9 who are at risk of disengaging from the education system.

The students visit the firm once a fortnight, and over lunch in the Boardroom are able to have one-on-one time with their mentors. Students and mentors always remain in a group situation, but are given activities to complete together covering topics like goal setting, respect, tolerance, stereotypes, etc. The students are encouraged to actively participate, and are given the time and attention by their mentors building confidence and self esteem.

The program runs for most of the school year, and the teacher's feedback on the students involved shows improvement in their attitude at school. There is less absenteeism, they are more focused, start to listen and participate in class, and show an improvement in turning in assignments and doing homework. Many of the students who were planning to leave school in grade 10 decide to continue their education through to grade 12 or higher.
